1. It is hereby notified, for information of all the Candidates of MA/MCOM/MCOM(IS)/MSW/MSC/M.LIB.I.SC./J&MC **CBCS** of all the Campus, Constituent, Affiliated & District P.G. Colleges, that the **IV-Semesters (Regular, Backlog & Improvement), III-Semester (Backlog & Improvement) and M.Sc. (Chemistry) 5 years Integrated Course IV, VI VIII & X Semester (Regular, Backlog & Improvement) and III, V, VII & IX-Semester (Backlog & Improvement)** Examinations are commencing in the Month of **September, 2020**. The Detailed Time-Table will be notified in due course.
2. Notification pertaining to M.A./M.S.W./M.Com./M.Sc./M.Com.(IS)/B.Lib.I.Sc./M.Lib.I.Sc./MJ&MC I & II Semester (Backlog and Improvement) will be issued separately.
3. Further, it is informed that the following candidates will have to **PAY RS.1000/- for each backlog paper** in addition to **normal examination fee** as per the University letter No.87/M/503/Acad/04.
 - i) M.A./M.S.W./M.Com./M.Sc./M.Com.(IS)/J&MC who were admitted during the Academic Year 2014-2015 & 2015-2016 (i.e. 14th & 15th Batch).
 - ii) M.Lib.I.Sc. (One Year Course) who were admitted during the Academic Year 2017-2018 (i.e. 17th Batch).
 - iii) The above (i) & (ii) backlog candidates are allowed to write their backlog paper as per **EXISTING CBCS syllabus** only & also advised to contact the Chairman, B.O.S. concerned. **IT IS MANDATORY**
4. This is the **last chance** for appearing for the backlog examinations who were admitted during the Academic Year **2014-2015** (i.e. 14 Batch with college code) and **2017-2018** of M.Lib.I.Sc. (One Year Course) (i.e. 17 Batch with College Code) respectively.
5. The candidates who were admitted **PRIOR TO 2014-2015 of Regular P.G. Courses & 2017-2018 of B.LIB.I.SC./M.LIB.I.SC.(One Year Course)** Academic Year are **NOT ELIGIBLE** to appear for any of their backlog papers.

ii) Principals are requested not to forward/submit the EAF of Not Eligible Candidates. The results of Not Eligible candidates will be cancelled at any stage, if they write the examination.

iii) All the I & II consolidated Internal Assessment marks, Seminar, Practical and Project marks of IV-Semester marks will be accepted through online. So, all the Principals are requested to submit through online only along with one hardcopy for verification.

7. As per University norms, all the backlog candidates of Non-Choice Based Credit System (Non-CBCS) belonging to 14th & 15th Batches with college code of affiliated colleges will be allowed as per existing CBCS syllabus only.

The principals are requested to forward all the Project Reports who have registered for IV-Semester Examination duly certified, along with 2 copies of Nominal Roll and "ONE COPY" of the Project Report of each student on or before 15.10.2020 keeping the other copy in the college, which should be produced at the time of Viva for the use of Examiner(s) deputed for conducting the Viva Examination on the specified date(s). Projects of such of those candidates who do not register for the IV-Semester Examination will not be accepted. The Principals are requested to contact the Head, of the Department concerned for their Viva-Voce & Practicals.

10. ALL THE REGULAR AND BACKLOG CANDIDATES SHOULD SUBMIT THEIR SEMESTER EXAMINATION FORMS THROUGH ONLINE ONLY.
11. The Principals are requested to transfer the Consolidated fee amount through online/NEFT/RTGS for credit into the "Registrar, O.U. Examination Fee fund Account" A/C No.52198262033 State Bank of India (SBI), O.U. Branch, IFS Code "SBIN 0020071".
12. The Principals will be held responsible for any lapse in transfer of amount from the bank to the "Registrar, O.U. Examination Fee fund Account.
13. Due to prevailing situation COVID-19 pandemic, the Principals are advised not to submit hard copies of EAF Application forms to the Examination Branch, O.U. The approvals of the forms will be given through online by the concerned sections of the Examination Branch. The Principals can verify the approval status in their College Logins. However, a copy of Nominal Roll need to be submitted along with the fee receipt.

14. All the EAF should reach the Examination Branch, O.U. on or before 23.09.2020. A Penal fee of Rs.1000/- will be collected per day after due date. The IV Semester (Regular) candidates must enclose their III Semester attested Hall Ticket OR Memo of Marks December, 2019 Examination and Backlog candidates must enclose the memos of their earlier examinations along with EAF.
15. Further, the Principals are requested to submit compulsory the detailed fee statement signed by the college principal otherwise the forms will not be accepted.
16. ELIGIBILITY FOR PAPER WISE IMPROVEMENT.
- i) The Regular Candidates, (i.e. 18th Batch) who are studying IV-Semester at present are only eligible for III-Semester paper-wise improvement.
- ii) The Regular Candidates (i.e. 17th Batch) IV-Semester who were already appeared in June, 2019 examinations are only eligible for IV-Semester Paper-Wise Improvement.
- iii) The M.Lib.I.Sc. (one year course) candidates (i.e. 18th Batch) II-Semester who were already appeared June, 2019 Examinations are only eligible for II Semester Paper-wise improvement.

Note :- 1. The EAF will not be accepted unless the college submits clearance certificate from the superintendent (stores) of the Examination Branch with regard to the account of 32 page booklet stationery.

2. The Examinations will be conducted tentatively in the month of September, 2020 as per the Government Directions from time to time.
